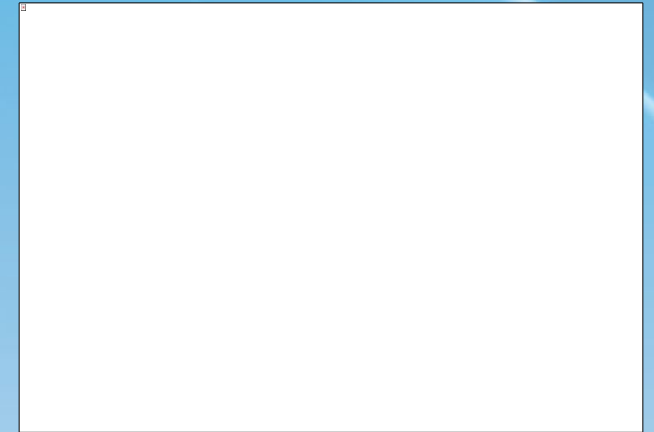

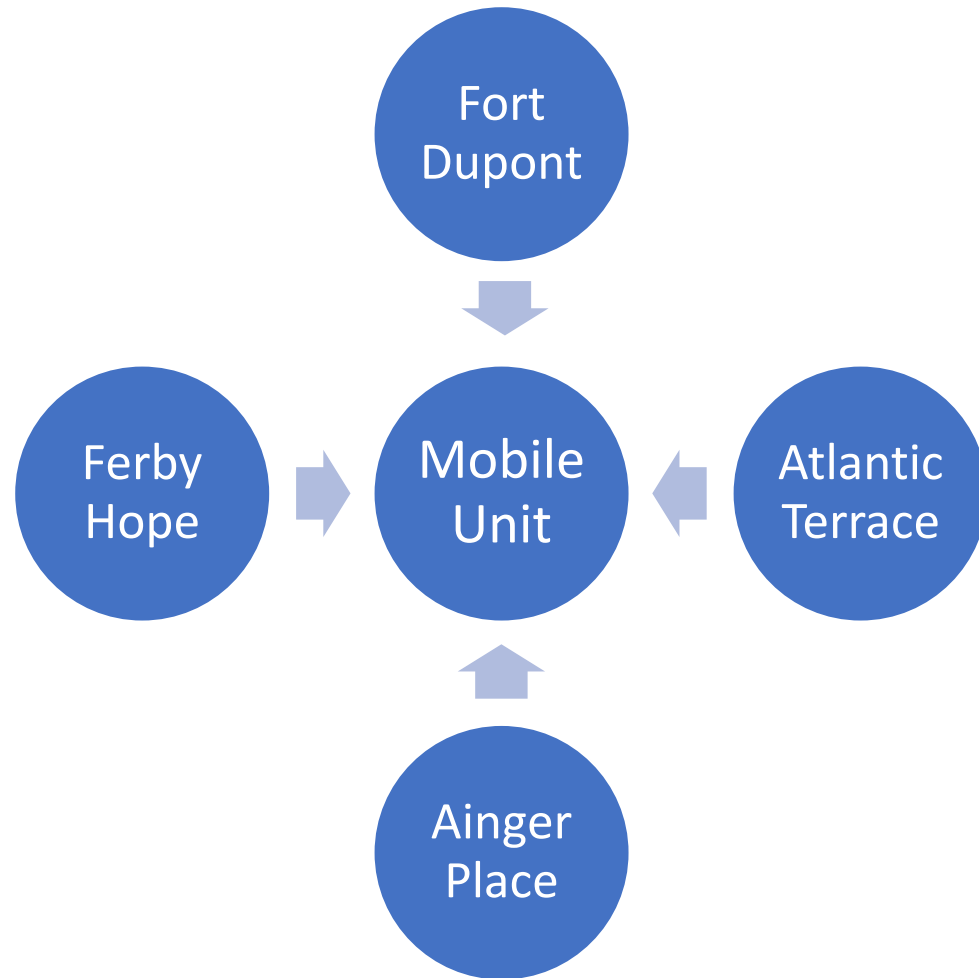

History of the Mobile Medical Program

- Extension of primary care medical home
- Prior Successes:
 - Partnered with specific neighborhoods (Wards 7 & 8)
 - **Fort Dupont**
 - **Atlantic Terrace**
 - **Parkland Apartments**
 - **Ferby Hope**
 - **Ainger Place**
 - **Grandma's House**
 - Residential facility for HIV infected babies and abused/neglected children
 - Medical and Dental Services
- At the program's peak – 3500 families annually

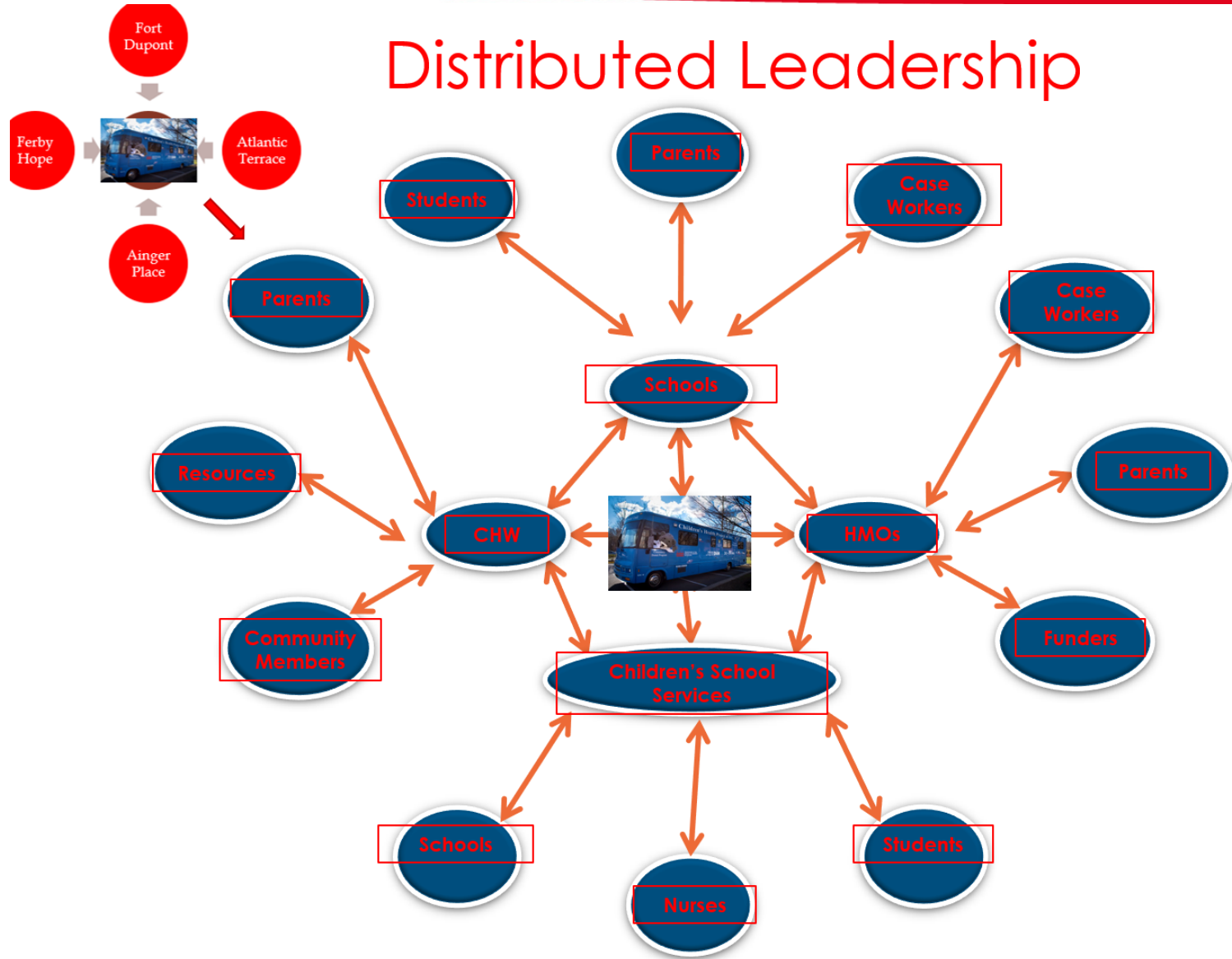


Challenges: Traditional Model with Changing Landscape

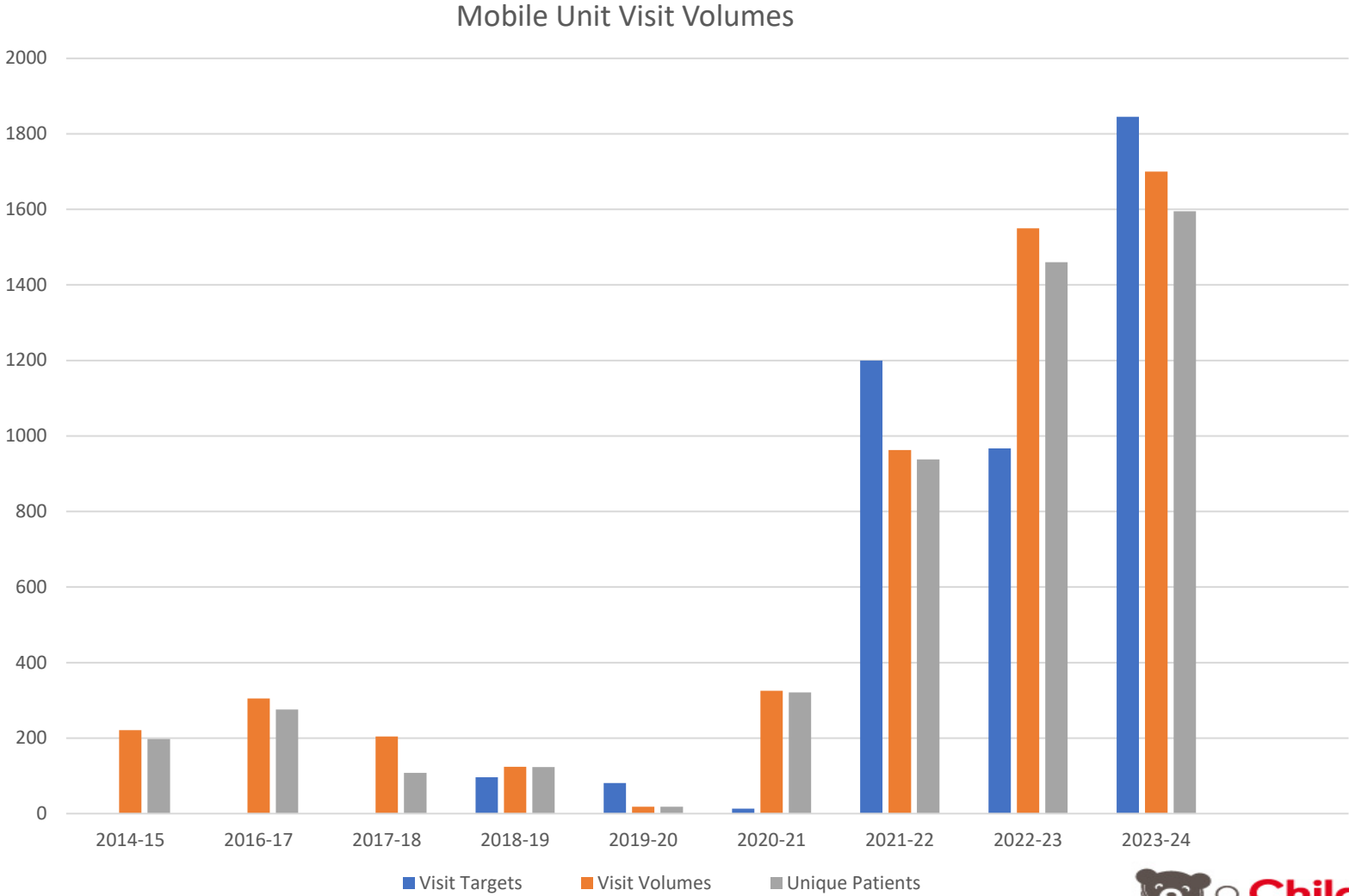


- Limited demand **OR** decreased effective community partnerships??

- Optics & advertisement

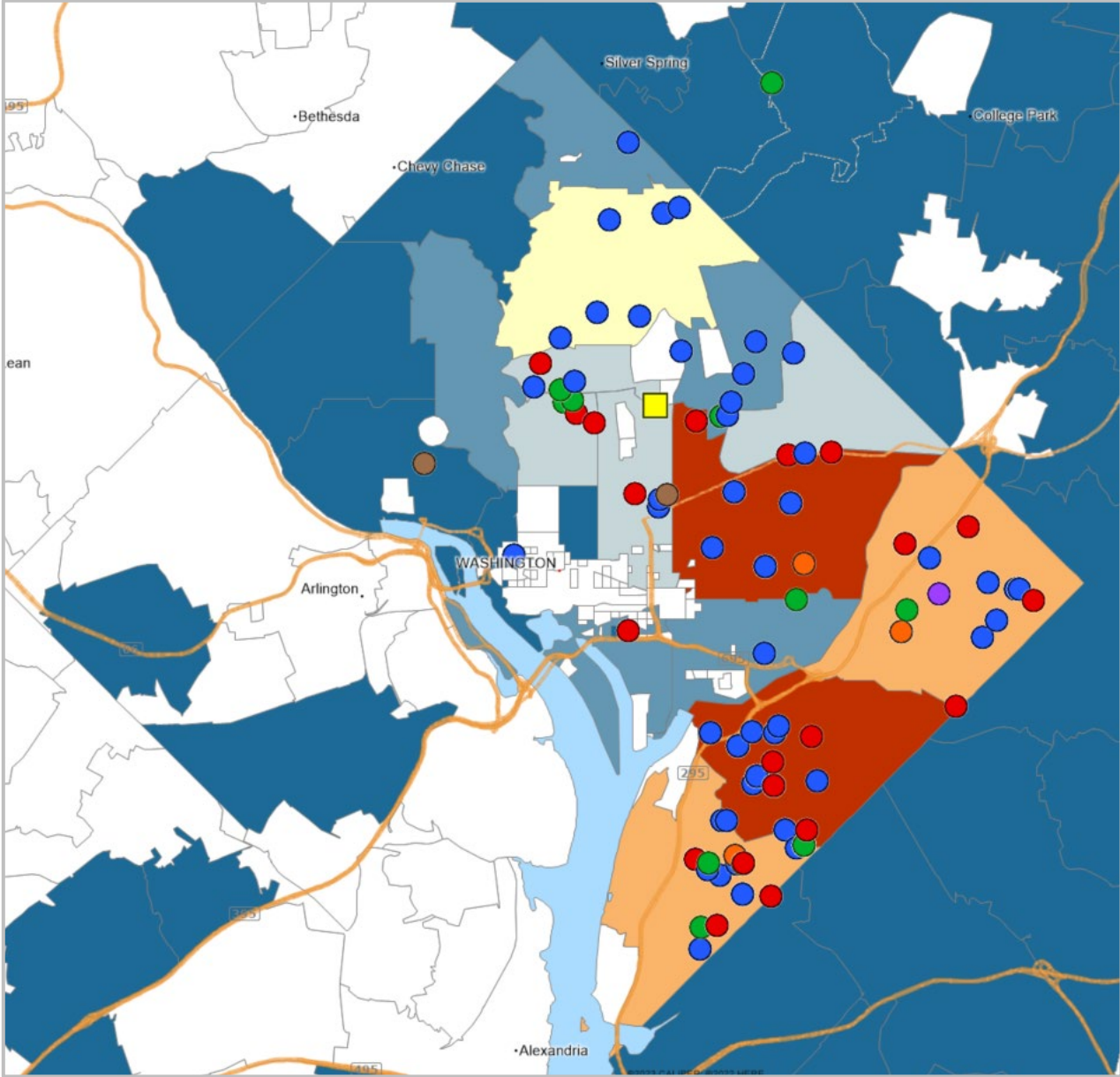

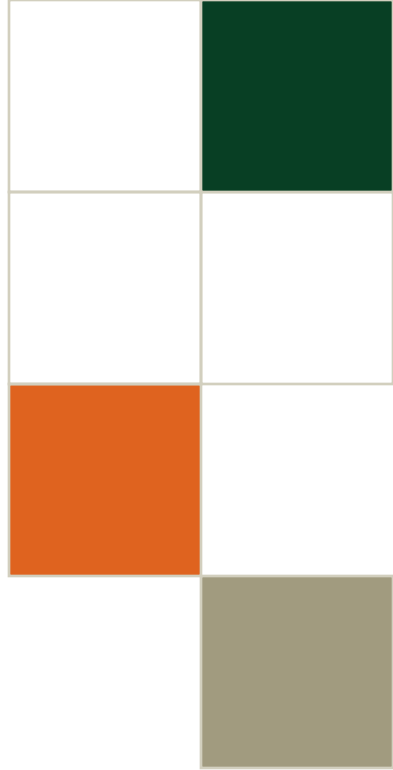

Community Partnerships & Distributed Leadership

- Routine meetings with community partners
 - Program introduction and identify community partner needs
 - Planning Meetings (2-3)
 - **Outline roles and responsibilities**
 - **Pre-visit Preparation**
 - Identifying families
 - Support families in completing appropriate documentation
 - Organizing appointment times for patients
 - **Day of Service**
 - Providing adequate space for mobile unit
 - Reminder calls during day of service
 - Managing patients as they arrive for appointments
- Inadequate recruitment or lack of follow through cancel and reschedule
 - Book another partner
 - ***Staff shifted back into the health center***

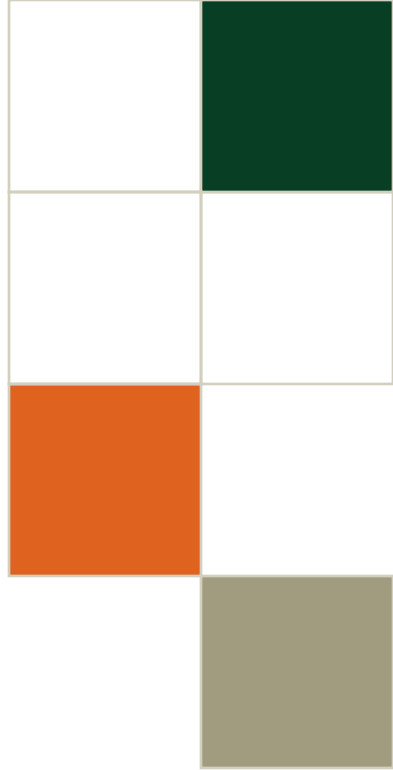

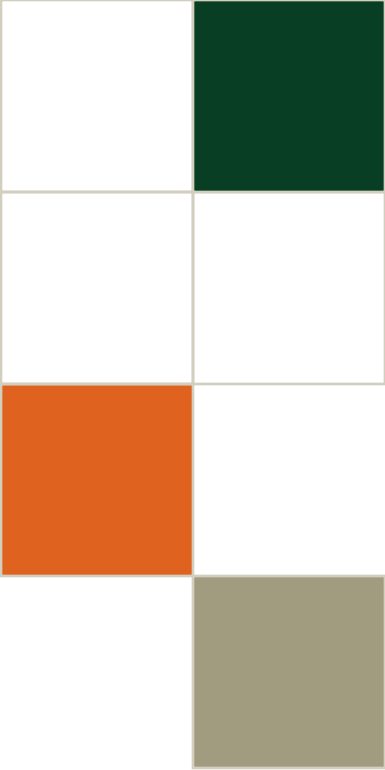




Pediatric Mobile Clinic (PMC)

A 38-foot bus customized to provide comprehensive primary health care services free-of-charge to children most in need, specifically those with no access or limited access to health care.





Shotz-2-Go! Mobile Unit (S2G)

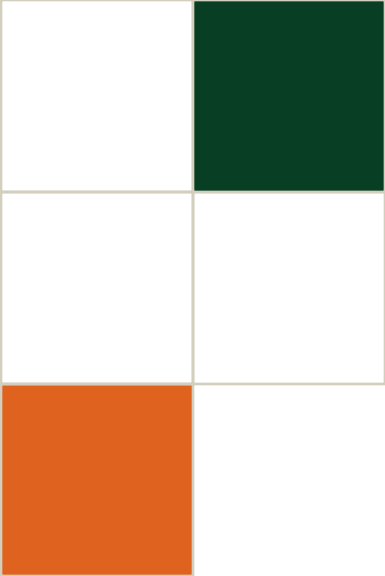
The Shotz-2-Go! program features a 40 ft. custom mobile medical unit dedicated to providing immunizations and medical care to children throughout Miami-Dade County.

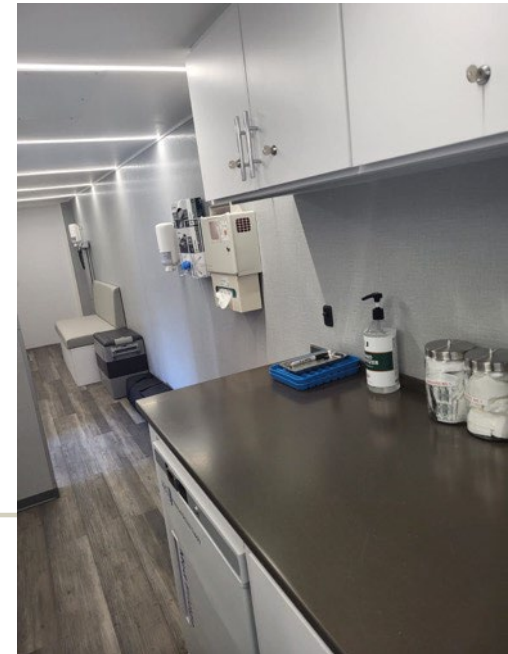

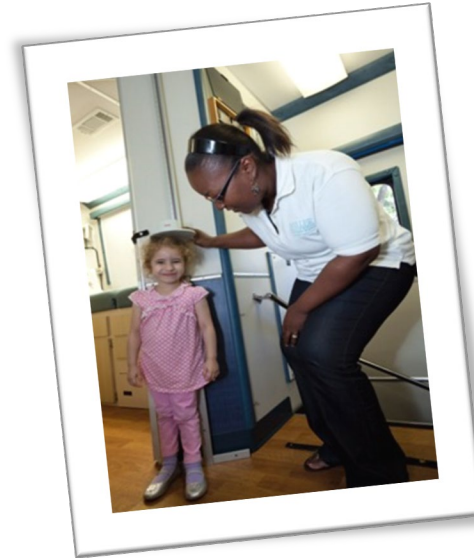
Services S2G

- Primarily Immunizations but has capacity for other services as well.
- Vaccine drives at targeted schools, health fairs, events



2023 Statistics

- Over 3000 clinical visits
- Nearly 650 mental health visits
- Nearly 10,000 childhood immunizations administered
- 2500 COVID-19 Vaccines administered
- 68% Hispanic; 25% Haitian; 5% African American; 2% Other

- Medical Students, Residents, Social Work interns, Psychology Ph.D Students, MD/MPH, MPH Students

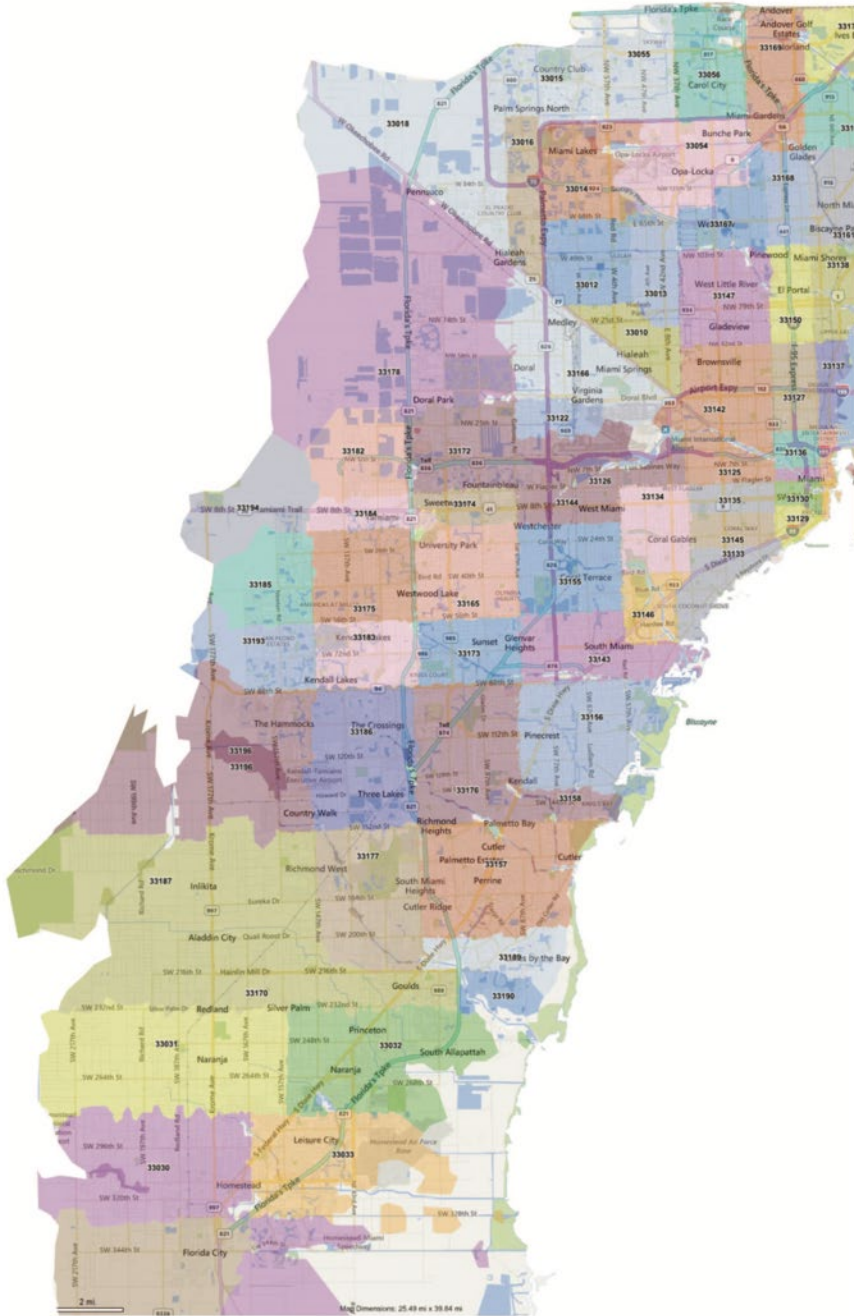


Communities We Serve

Areas include Homestead, Florida City, Little Haiti, Sweetwater, Miami Beach, West Kendall, Little Havana, Doral.

In addition, the unit participates in community health fairs, back-to-school events.



Our Patient Population

- Children from all over the world
- Many are undocumented
- High percentage from Latin America – entitlements depend on country of origin
- Recent increase in children from Central America and Venezuela
- 25% of patients from Haiti

The SHOTZ-2-GO! mobile unit will be dedicated solely for the purpose of providing immunizations to minority children in schools throughout the county.

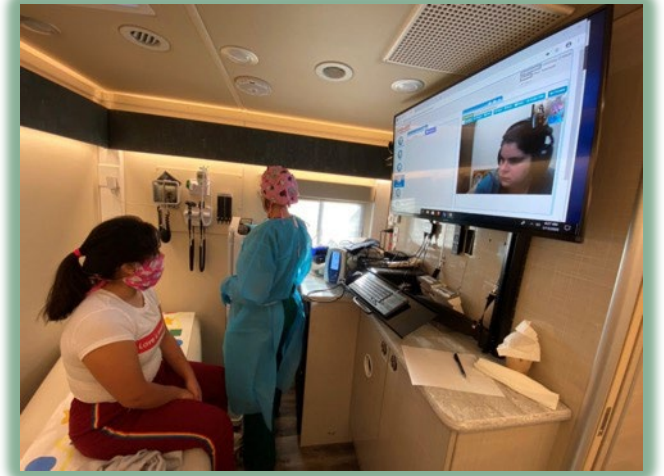

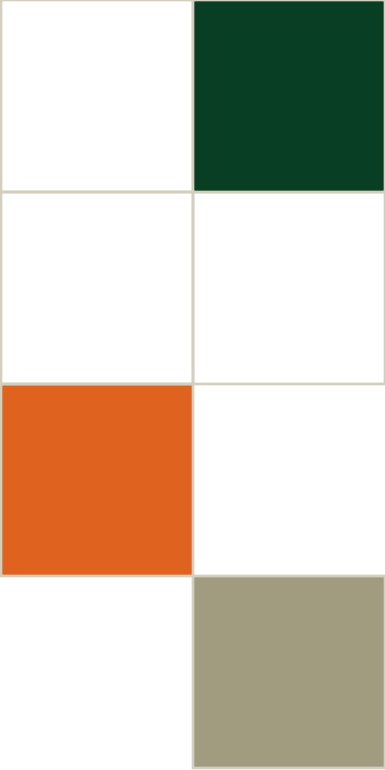

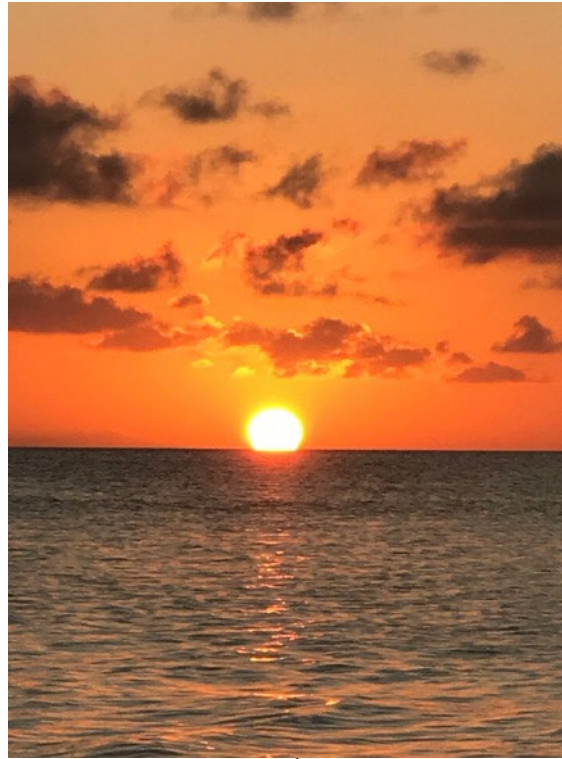

Background/History

- **Oct 2019:** Launched program!
 - First vehicle provided by MedEx Ambulance Service
 - Initial clinical services:
 - *Immunizations*
 - *School/Sports Physicals*
 - *Well-Child Care*
- **Spring 2020:** Pandemic
 - COVID-19 community vaccination clinics
 - COVID-19 testing in schools
- **Spring 2022:** Awarded Congressionally-Directed Spending
- **Aug 2023:** Acquired new vehicle!

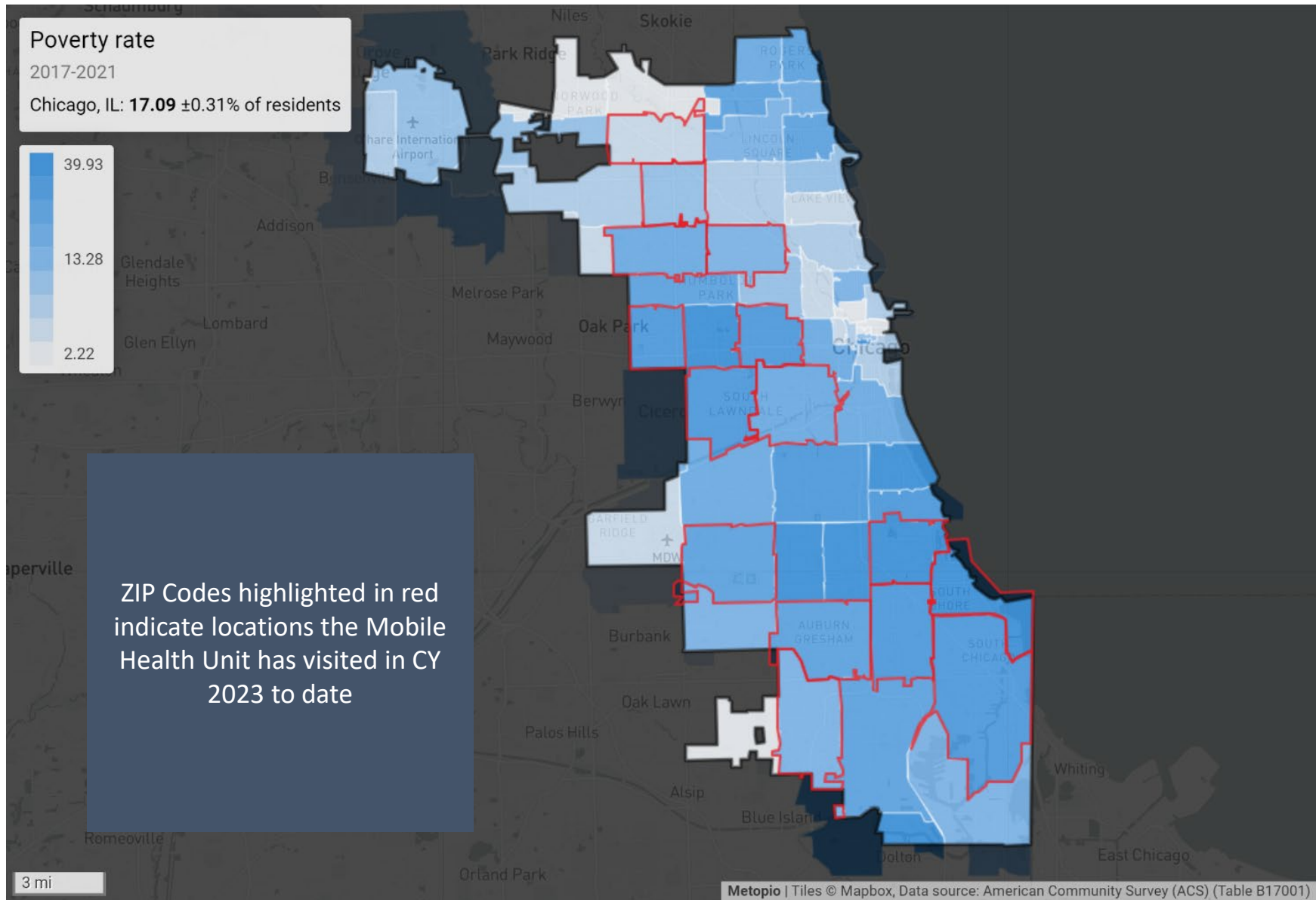
